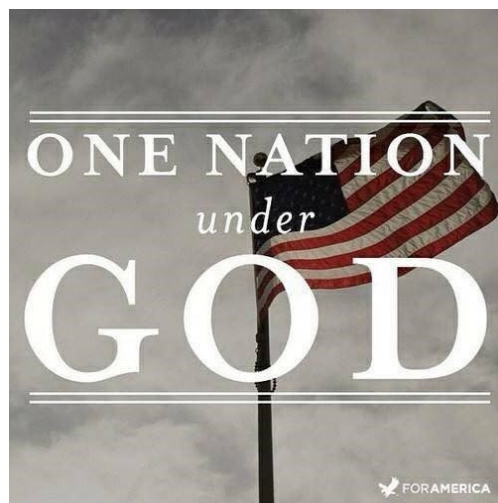

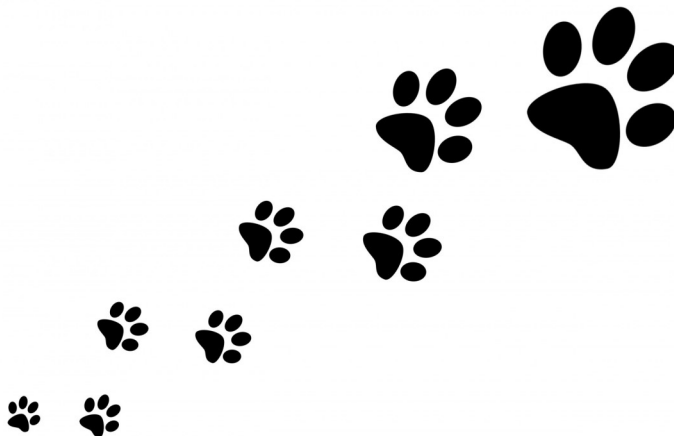

The Ocmulgee Water Trail Partnership, Inc. (OWTP) is sponsoring the third annual paddle on the Ocmulgee River. This year's paddle will begin at the Lumber City Landing on the Ocmulgee River and continue past the confluence of the Ocmulgee and Oconee Rivers, which forms the Altamaha River, and ends at Towns Bluff in Jeff Davis County.

The paddle is open to everyone and has had 70-90 paddlers who travel from all parts of Georgia and the surrounding states. In the past two years, kayaks were the main water craft, followed by canoes. Paddlers vary from Senior citizens to pre-teens with their parents.

All participants pay a registration fee and receive a tee shirt and meal.

After the day's river travel and meal, the OWTP has a door prize drawing as a demonstration of our appreciation for their participation.
